PLACEMENT POLICY---Please review program details before selecting program for your child. Although your child may have satisfied all requirements considered for advancement, we reserve the right to place your child in a category deemed appropriate by the head instructor. The head instructor will place the most qualified children first, on a space available basis.

REFUND POLICY---A 50% tuition refund shall ONLY be made for a child that withdraws from the program during the first five days from the beginning of the session.

Please read and sign below:

We wish to enroll our daughter/son in the Jr. Sailing Program offered by the Youngstown Yacht Club Junior Sailing Foundation. We understand that it is our responsibility to transport the student to the club grounds in time for the scheduled class and to pick her/him up after the class. Parents will supply the student with a daily lunch sealed in a labeled, waterproof plastic bag. The student must have and wear a Coast Guard approved PFD when on the water. Further, we certify that the applicant is able to swim, is in good health and able to participate in outdoor physical activity. The student is expected to follow the direction of the Sailing Instructor, and behave in a reasonable fashion and we understand that a student may be dismissed from the program in the best interests of the safety of the child and the program and that this decision shall rest with the Junior Sailing Head Instructor.

We further understand that a sailing program entails an element of hazard and in this respect we accept full responsibility for the presence of our family in this course and release the Youngstown Yacht Club, its Directors and Junior Sailing Instructors from all responsibility. We hereby acknowledge that we have read and affirm the entire contents of the application.
